From Bus Station: The venue is just about 750m from Rupnath Brahma Inter-State Bus Terminal (ISBT)

Q8 What is included with my booth?

As an exhibitor, you will have the ability to make your space as fun as the service you're offering. All stalls will have walls on three sides, EXCEPT stall numbers B24, B25, B26, B27, C23, C24, C25, C26, D1, D2, D3, D4, D5, D6 and D7 where the stalls will be separated from each other only by the behind wall, but not the side walls.

Please note that each expo attendee will be offered a floor map, and your booth will come with a sign for your company name.

2 chairs, 1 table and electrical socket for laptop and mobile charging will be made available.

The exhibitors are encouraged to prepare for **live demonstrations**. **Separate electrical connections** will be provided based on the requirement already placed during registration. Q10 Demonstration Guidelines

Exhibits must be positioned/displayed/demonstrated such that they will not intrude into the pathway/ public space or cause a hazard to visitors/other exhibitors.

Sticking posters/ handbills and putting banners on the premises is strictly prohibited.

All stalls need to be manned by the exhibitors throughout the exhibition open hours, ie on 28th and 29th February 2020 from 10 am to 5.30 pm.

Q11 Will there be security provided to my stall?

Though the general security is provided, the protection and maintenance of the individual stalls and their belongings rests with the exhibitors. Please note that SELCO Foundation, or its organizing partners will not be responsible for any theft/loss/damage of your appliances and belongings.
